



PARTICIPATION AND DIVE DECLARATION & DATA PROTECTION

AMPHORA KUPA DIVING DIVE AND WAIVER, RISK ASSESSMENT AND INDEMNITY AGREEMENT for the conduct of diving activities, diving related activities and diving related events (hereinafter referred to as the "Dive" or "Program").

I, the undersigned Participant, hereby declare that I have the right to act on my behalf and in my interest without restriction.

I acknowledge and agree that Amphora Diving Club (1027 Budapest, Varsányi Irén u. 33/b) (hereinafter referred to as "Organizer") by signing the Diving and Risk Assessment Agreement for the AMPHORA KUPA diving activities (hereinafter referred to as "Diving Statement"), I agree to be bound by the provisions of the Agreement.

- 1) I acknowledge and accept all risks associated with participation in the Dive.
 - a. I have read the Competition and Entry Rules, accept them and agree to be bound by them.
 - b. I acknowledge that the Organizer accepts no responsibility for any health risks incurred by the Participant as a result of participation in the Dive.
 - c. I acknowledge that there are risks associated with participating in the Dive, which may be serious or fatal.
 - d. I acknowledge and agree that it is my responsibility to determine whether I am in good physical and health condition to participate in the Dive
 - e. I further certify and attest that I am fit to participate in the Dive.
 - f. I declare that I do not suffer from any mental or physical disorder which, if I participate, would endanger me or any other Participant or prevent them from participating safely in the Dive.
 - g. I accept responsibility for the condition and suitability of the equipment I use and for my conduct on the Dive.
 - h. I also assume all risks associated with participation in the Dive.
 - i. I understand that the rules and procedures for diving are for my own safety and health and that failure to follow them may put me in danger while diving.
 - j. I understand that compressed air diving carries certain risks; decompression sickness, embolism or other overpressure injury can occur.
 - k. I also understand that the Dive may take place in places that are distant in time or space - or both - from such a hyperbaric chamber. Nevertheless, I decided to participate, despite the fact that there is no hyperbaric chamber near the dive site.
- 2) By signing this Agreement, I hereby release, in particular, but not exclusively, the following entities and persons from any and all liability which they may incur, from which release is not excluded by law, waive all claims against them and in any event perform to them in contract
 - a. Organizer, other Participants, administrators, volunteers, officers, all other persons or entities, and the facility through which the Program is conducted, who participate in the organization of the Dive, collectively, the "Released Parties"
 - b. I acknowledge that the Released Parties shall not be liable for any death, personal injury or other loss which I suffer or cause or which results from my own conduct or from any matter or circumstance within my control which is the result of my own negligence.
 - c. I hereby release and discharge the Released Parties from all liability and waive all claims or demands arising directly or indirectly out of any willful misconduct or other act.
- d. I waive any and all claims, including but not limited to all legal fees, costs and expenses, and all future claims, that I may have in connection with or arising out of my registration or participation in the Dive.
- e. For the purposes of this Agreement, property damage and other damage shall mean, in particular, but not limited to, death, personal injury, total or partial paralysis, damage to property, theft and any other damage arising from theft and any other damage, and all Claims for first aid, medical care or treatment and decisions in this regard, whether at the Event venue or elsewhere.
- 3) I hereby declare and undertake to observe, study and examine the Dive Site myself prior to participating in the Dive.
- 4) I further declare that if I believe or become aware that there is any security risk, I will immediately notify the Promoter.
- 5) I further declare that I undertake to pay all costs in this respect which I incur in connection with my participation in the Event and which are not covered by social security or my insurance. I hereby declare that I will assume the payment of all costs detailed in this clause from the Released Parties.
- 6) I expressly acknowledge that the Organizer has the right, at its sole discretion, to postpone, modify or cancel the Dive if, in its opinion, the conditions for the safe conduct of the Dive are not met on the day/time of the Dive.
- 7) If any provision of this Agreement is held to be invalid or unenforceable, in whole or in part, the validity of the remainder of this Agreement shall not be affected. Any invalid or unenforceable provision shall automatically be replaced by a valid or enforceable provision that most closely approximates the original intent.
- 8) The Organizer shall not be liable for any personal injury or damage to property, except for damage caused by its gross negligence. The above limitation of liability shall also apply to the representatives of the Organizer, its support staff and third parties providing services to the Organizer in connection with the conduct of the Dive, and to third parties with whom the Organizer has a contractual relationship for the purpose of conducting the Dive.
- 9) I acknowledge that I participate in the Event at my own risk and that I am responsible for the risks associated with my participation in the Event.
- 10) I acknowledge that if I do not agree to be bound by this Agreement, I will not be eligible to participate in the Event. I further acknowledge that participation in the Event constitutes acceptance of the entire Agreement
- 11) I have read this declaration before signing and fully understand its contents.

INFORMATION NOTICE AND CONSENT FORM

The Organiser informs participants about the following in relation to their participation in the Competition.

- 1) Participants acknowledge and expressly agree that the registration and the personal data provided during the Contest to be processed, processed and stored by the Organiser for the purposes of participation in the Contest and related communication and promotion, for the successful running of the Contest and for the purposes of fulfilling the provisions of these Contest and Entry Rules.
- 2) Personal data processed: surname, first name, date of birth
- 3) By registering for the Contest, participants acknowledge that during the entire duration of the Contest, photographs and video recordings will be taken, which the Organizer may use and publish in edited and edited form, without any time and territorial limitation, for marketing and communication purposes in electronic and print media describing and promoting the Contest, but only without infringing the participants' personal rights.
- 4) Participants also acknowledge that the Organiser may disclose the data recorded during registration and the edited or edited footage of the Competition to its partners involved in the preparation and implementation of the Competition for marketing or communication purposes only to the extent necessary for the successful implementation of the Competition.
- 5) Each participant has the right to request information from the Organiser at any time about the processing of his/her personal data, and may request the deletion or correction of his/her data. Participants may withdraw their consent to the processing of their data by email at any time. Participants who believe that their personal data has been infringed by the Organiser may contact the National Authority for Data Protection and Freedom of Information and the courts.

- 7) Participants can find detailed rules on data management in the Data Management Policy on the Organiser's website. Data management in relation to the Competition is governed primarily by this Notice, supplemented as appropriate by the Rules, in particular with regard to the rights of participants.

Based on the above information, as a participant of the Amphora Cup Orienteering Diving Competition, I declare:

- 1) the provision and processing of the data requested in the Competition Rules and during registration for participation in the Competition is based on my voluntary consent.
- 2) Before giving my consent, I received detailed and clear information from the Organiser about the processing of my personal data
- 3) I acknowledge that during the entire duration of the Competition, photographs and videos will be taken, which may be edited and published on the public website of the Organiser and its Partners, and may be used by the Organiser in press communications about the event.
- 4) I give my explicit and unambiguous consent to the Organiser to process my personal data, including photographs and videos taken during the Competition, as specified in this declaration.
- 5) The legal basis for data processing is the voluntary consent of the data subject in accordance with Act CXII of 2011 on the Right to Informational Self-Determination and Freedom of Information (Act on Information).
- 6) Personal data processed: surname, first name, e-mail address, telephone number
- 7) The purpose of data processing is to ensure participation in the Competition, to maintain contact with participants and to comply with the Competition and Participation Rules.
- 8) Duration of processing: 1 year unless consent is withdrawn
- 9) Place of data processing and storage: the Organiser's headquarters and the computers
